NAVIAMOS FOR THE IMPLEMENTATION OF PROTECTIVE SERVICES PROGRAM FOR THE POOR, MARGINALIZED AND VULNERABLE INDIVIDUALS, FAMILIES AND COMMUNITIES IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
