MUNICIPAL ORDINANCE NO. 19-10-247

**AN ORDINANCE NAMING, CALLING, AND REFERRING ALL BONA FIDE
RESIDENTS OF BULALACAO, ORIENTAL MINDORO
"BULALACAONONS" FOR ALL INTENTS AND PURPOSES**

WHEREAS, while every citizen of this country is called Filipino, it is important that there is a word to be used in calling residents of each locality in order to emphasize identity, to provide reference, and to avoid confusion;

WHEREAS, such official name must have association with the character, culture, and history of the people and place so that the reference shall be distinct and peculiar;

WHEREAS, calling a resident or residents of Bulalacao, Oriental Mindoro "Bulalacaonon" or "Bulalacaonons" respectively, shall facilitate identification from residents of other places which have the same name of Bulalacao;

Section 5. Expenses, if there would be any, in connection with the implementation of this Ordinance shall be charged to related appropriations under the concerned offices or units.

Section 6. A police officer, barangay official or tanod, or any legal aged and bona fide Bulalacaoon may apprehend and bring those who shall violate the herein mentioned prohibited act to the barangay or municipal jail for detention not exceeding twenty (24) hours.

Violation of the prohibited act shall be punishable by the following:

- First offense Fine of five hundred pesos (PhP 500.00) and/or community service of at least eight (8) hours
- Second offense Fine of one thousand pesos (PhP 1,000.00) and/or community service of at least sixteen (16) hours
- Third offense Fine of one thousand five hundred pesos (PhP 1,500.00) and/or community service of at least twenty four (24) hours

The collected fine shall be apportioned as follows:


- a. Forty percent (40%) of the amount shall go to the apprehending person/s;
- b. Sixty percent (60%) of the amount shall go to the LGU of Bulalacao.

Payment of fine shall be done in the Municipal Treasury Office (MTO) which shall issue official receipt of the amount paid. The MTO shall grant the incentive fraction to the apprehending person/s within seventy two (72) hours after the receipt of the fine, following the usual accounting rules and regulations.

The Municipal Information Office or the equivalent unit under the Office of the Municipal Mayor shall disseminate the contents of this Ordinance thru the social media or any traditional means

Any officer or employee of the LGU of Bulalacao who shall disregard or neglect the implementation of this Ordinance shall be administratively dealt with and such shall be a ground for suspension or dismissal subject to pertinent provisions of the Civil Service laws and rules.

Section 7. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.


