MUNICIPAL ORDINANCE NO. 18-02-193

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 14, SERIES OF 1992, PROVISION ON CRITERIA AND REQUIREMENTS FOR THE ACCREDITATION OF PEOPLES' ORGANIZATION (PO's) AND NON-GOVERNMENTAL ORGANIZATION (NGO's) FOR MEMBERSHIP IN THE MUNICIPAL DEVELOPMENT COUNCIL

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Section 1 of Ordinance No. 14, series of 1992, provision on Criteria and Requirements for the Accreditation of PO's and NGO's is hereby amended as follows:

"Section 1.The following criteria and requirements must be fulfilled by any People's Organization (PO's) or Non-Governmental Organizations (NGOs) before accreditation for membership be made;


Handwritten signatures and initials at the bottom of the page.

1. Letter of application for accreditation or duly approved board resolution requesting for accreditation of the PO's and NGO's;
2. Duly accomplished application form for accreditation;
3. Certificate of registration, with any national government agency, supported by Articles of Incorporation and Constitution and By-Laws;
4. List of organization's officers and members with record of membership contributions duly certified by the Secretary;
5. Documented annual accomplishment reports for the last two years;
6. Financial reports, if any (to include statement of current operations, balance sheets, income statements, cash flows, etc.);
7. Minutes of the last general assembly showing new set of officers, if any;
8. Certification of the concerned Punong Barangay as to the organization's existence in the barangay;
9. Certificate of affiliation to federations (for non-cooperatives), if there is any;
10. Certificate of good standing/compliance (for cooperative only);
11. Resolution of undertaking;
12. Registration fee amounting to PhP500.00 which shall be paid to the Municipal Treasury Office upon application for registration; and
13. Annual accreditation fee amounting to PhP500.00 shall be paid to the Municipal Treasury Office within the first month of every year after registration."


SECTION 2. This Ordinance shall take effect immediately.






