MUNICIPAL ORDINANCE NO. 19-09-241

AN ORDINANCE GRANTING MONTHLY HONORARIUM TO PERSONS WITH DISABILITIES (PWDs) LEADERS IN THE AMOUNT OF EIGHT HUNDRED PESOS (Php800.00) FOR THEIR BASIC NECESSITIES IN PERFORMING THEIR FUNCTIONS

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. PURPOSE. Under Section 458 (a) of the Local Government Code of 1991 the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approved resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the said Code. The provision of monthly honorarium to Persons with Disabilities (PWDs) may be considered among the programs of the municipality for the welfare of PWDs Leaders performing different roles and responsibilities related to PWDs improvement such as organizing activities and projects for their members and for other constituents of their respective barangays. Their position is a voluntary position that does not have wages and salaries in return of their functions. They attend meetings, trainings and seminars through the Municipal Social Welfare and Development Office (MSWDO) for updates, schedules and activities launched and funded by the Local Government Unit and other organizations. It could be taken into consideration to allow PWDs Leaders to receive monthly honorarium for their basic necessities in performing their functions basically for their transportation and meals.

SECTION 2. COVERAGE. All PWDs Barangay Coordinators of fifteen (15) barangays including one (1) Person with Disability Affairs Officer (PDAO) shall be entitled to receive a monthly honorarium of Eight Hundred Pesos (PhP800.00) each.

SECTION 3. APPROPRIATION. The honorarium subject to the availability of fund, shall be taken from the General Services Fund of the Office of the Municipal Mayor. The said honorarium shall be included in Executive Budget every year thereafter unless revoked or amended by legislative action.


Disbursement of fund shall be subject to usual budgeting, accounting, disbursing, and auditing laws, rules, and regulations.

SECTION 4. SEPARABILITY CLAUSE. If for any reason or reasons any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.


