

WHEREAS, the burial assistance shall be fixed at fifteen thousand pesos (Php15,000.00) as maximum assistance to be given thru the Municipal Social Welfare and Development Office (MSWDO) and this shall include the provision of an ordinary white casket, transport of the corpse, embalming, funeral wake for seven (7) days and interment, **Now, therefore**,

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO THAT:

Section 1. Definition of Terms. The terms and phrases as used in this ordinance shall mean the following:

- a. **Indigent Family-** shall mean a family or individual person living on their own who earn a combined or individual monthly income of less than five thousand pesos (Php5,000.00) and who do not own personal properties worth more than ten thousand pesos (Php10,000.00) as certified by the Punong Barangay in their respective barangay.
- b. **Funeral Services-** refer to the preparation of funeral embalming services and interment including the provision of ordinary white casket and wake services.

Section 2. Grant of Standard Burial Assistance for Indigent Families. The amount not exceeding fifteen thousand pesos (Php15,000.00) shall be granted to each indigent family by the accredited funeral homes identified by the Municipal Social Welfare and Development Office (MSWDO). The grant of burial assistance under this ordinance is without prejudice to the right of beneficiary to avail other financial assistance outside of the Local Government of Bulalacao, Oriental Mindoro;

Section 3. Requirements for Availing Discount. Before the indigent family can avail the burial assistance, the following documents shall be prepared and submitted to the MSWDO;

- a. Certified true copy of Death Certificate;
- b. Certificate of Indigency from the Barangay that certify him that he belong to an indigent family as defined under Section 1 of this ordinance Provided, however, that the certification shall not be a requirement before the deceased could avail of the services of the funeral parlor.

Section 4. REIMBURSEMENT. The Municipal accredited funeral homes granting funeral services discount to indigent families shall reimburse the cost of the discount from the MSWDO upon approval of the head of office provided, proper certification as to the veracity of the claim is certified true and correct by the MSWDO.

Section 5. IMPLEMENTATION. The Municipal Social Welfare and Development Office (MSWDO) shall implement this ordinance and shall provide the necessary implementing rules and regulations to carry out the objectives of this ordinance.

Section 6. SEPARABILITY CLAUSE: If any provision or part hereof is found invalid or unconstitutional, the remainder of the ordinance or the provision/s not otherwise affected shall remain valid and existing.

Section 7. Repealing Clause. Any ordinance, executive order or issuance, administrative order, rules and regulations contrary to or inconsistent with the provision of this ordinance is hereby repealed or modified accordingly.

This ordinance shall take effect after fifteen (15) days of posting in at least three (3) conspicuous places in the Municipality of Bulalacao, Oriental Mindoro in compliance with Section 59, Chapter 3, Title II, Book 1 of the Local Government Code of 1991 (Republic Act No. 7160).




