

NOW THEREFORE; In view of the foregoing premises, be it ordained by the Sangguniang Bayan, in session ASSEMBLED that:

SECTION 1. Composition. Municipal Tricycle Franchise and Regulatory Board (MTFRB) is hereby created with the following;

SECTION 2. Meeting and Quorum of the Board . The Board shall meet at least once every quarter or as often as may be necessary, on such a day and time as it may fixed, the presence of at least majority its member shall constitute a quorum.

SECTION 3. FUNCTION OF THE BOARD –The Board shall have the following functions:

- Recommend fare rates (fare structure);
- Recommends regulatory measures affecting tricycle operations in convenience and orderly tricycle operation. It shall take into account the ideal viable and competitive member or unit that should operate with the Bulalacao, Oriental Mindoro;
- Recommend whether to add or reduce additional franchise to the Sangguniang Bayan for approval;
- Evaluate/access, recommend request from tricycle, drivers and operators association (TODA) to Barangay Councils and other affected sector relative to Tricycle Operation;
- Update the Local Chief Executive and the Sangguniang Bayan of the status of Tricycle Operation in the various agencies/officer to streamline the efficient and effective operation of the (MTFRB);
- Perform other related duties/responsibilities for effective and liable tricycle operation in the municipality of Bulalacao as provided for by existing laws regulation and ordinances.

Legislative Body shall have the power to approve and renew franchises. The Local include evaluation and verification of franchise applications on change of routes, change of unit renewals through the technical secretariat who shall process for approval and granting of franchise for new issuances and transfer to the Sangguniang Bayan pursuant to Art. 3. Sec 446 par 3. (VI) of the Local Government Code of 1991.

SECTION 5. REPEALING CLAUSE . Other Ordinance, Resolution or Executive Order inconsistent with the provision of this ordinance is hereby repealed.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao;






