**MUNICIPAL ORDINANCE NO. 20-05-260**

**AN ORDINANCE REQUIRING THE USE OF FACE MASKS OR FACE COVERINGS OR FACE SHIELDS IN PUBLIC PLACES WITHIN BULALACAO, ORIENTAL MINDORO AND IMPOSING PENALTIES FOR VIOLATION THEREOF**

**WHEREAS**, President Rodrigo Roa Duterte placed the entire country in a state of public health emergency thru Proclamation 922 and declared a state of national calamity thru Proclamation 929 as a result of the World Health Organization's declaration that COVID 19 is a pandemic;

**WHEREAS**, the Local Government Code of 1991 provides that local government units shall ensure and promote health and safety and shall preserve the comfort and convenience of their inhabitants within their respective territorial jurisdictions;

**WHEREAS**, Governor Humerlito A. Dolor directed the use of face masks or other face covers when outside residences in the whole province thru Executive Order No. 27, s. 2020;

Be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

**Section 1.** It is the policy of the Local Government Unit of Bulalacao to protect all its inhabitants from severe acute respiratory syndrome caused by identified pathogens.

**Section 2.** All residents, visitors, and transients in Bulalacao, Oriental Mindoro shall comply with the mandatory wearing of face masks or face coverings or face shields when going out of residence or when in public places during the period of national public health emergency or during community quarantine period brought about by pathogens transferred through droplets, sneezing, coughing, and similar means. Wearing of face masks or face coverings or face shields inside the residence shall be strongly recommended.

**Section 3.** All barangay officials and workers and all police and other uniformed personnel assigned in this municipality shall enforce and implement this Ordinance.

**Section 4.** Violators shall be given a lecture on the importance of disease prevention through wearing of face masks or face coverings or face shields by barangay health workers if apprehended by barangay officials and workers, or by personnel of Municipal Police Station or Municipal Health Office if apprehended by police personnel and other uniformed personnel.

**Section 5.** Any person violating this Ordinance shall be subject to the following penalties:

First offense	Fine of two hundred fifty pesos (PhP 250.00)
Second offense	Fine of five hundred pesos (PhP 500.00)
Third offense	Fine of seven hundred fifty pesos (PhP 750.00)
Fourth and succeeding offense	Fine of one thousand pesos (PhP 1,000.00)

Parents shall pay the penalty to be imposed on their children aged below 18 years old.

Fines collected in connection with the implementation of this Ordinance shall accrue to barangay treasury if apprehension was made by barangay officials and workers or to municipal treasury if apprehension was made by police personnel and other uniformed personnel.

**Section 6.** Any ordinance contrary to or inconsistent with this Ordinance is hereby repealed or modified accordingly.

**Section 7.** If any provision of this Ordinance is declared illegal or invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.


**Section 8.** This Ordinance shall take effect immediately upon approval and shall be posted in all barangay halls and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.




