MUNICIPAL ORDINANCE NO. 20-04-259

AN ORDINANCE GRANTING MONTHLY COMMUNICATION ALLOWANCE TO MS. SYRIXTY MAGCALAYO OCAVA, NURSE I IN MUNICIPAL HEALTH OFFICE IN THE MAXIMUM AMOUNT OF TWO THOUSAND PESOS (Php2,000.00)

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro;

SECTION 1. STATEMENT OF POLICY. It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro (LGU of Bulalacao) to maintain empowered, high morale, and productive workforce. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991 to determine salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds.

SECTION 2. ENTITLEMENT. Ms. Syrixty Magcalayo Ocava, in her capacity as the incumbent of Nurse I position who regularly sends reports and as the designated personnel attending to Animal Bite and Treatment Center (ABTC), Municipal Epidemiology Surveillance Unit (MESU) Coordinator, Adolescent Program Coordinator, TB Coordinator, Mental Health Program

Coordinator and Non Communicable Program Coordinator shall receive communication allowance, covering mobile phone and internet expenses, in the maximum amount of PhP2,000.00 every month. However, if she would incur unauthorized absences or if she would be on leave of absence for at least ten (10) calendar days, she shall not receive this allowance.

The concerned employee shall start receiving this allowance effective March 1,2020 and shall continue to receive it as long as she attends to functions concerning reports and ABTC.

SECTION 3. NON-INCLUSION IN INCREASE. This Ordinance shall not cover the PhP1,000.00 across the board monthly increase as mentioned in Section 3 of Special Ordinance No. 16-09-41.

SECTION 4. FUND. Fund for this Ordinance shall be charged against the Maintenance and Other Operating Expenses of the Office of the Municipal Mayor for the current year. Annual appropriation for this allowance shall be allocated in the Municipal Annual Budget FY-2021 and every year thereafter under the Municipal Health Office.

SECTION 5. FUND DISBURSEMENT. Disbursement shall only be allowed upon presentation of statement of account or official receipt of payment for communication expense issued by legitimate retailer or dealer of communication services or products.


SECTION 6. REPEALING CLAUSE. Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

SECTION 7. EFFECTIVITY. This Ordinance shall take effect on March 1,2020;






