RESOLUTION NO. 20-01-001

EARNESTLY REQUESTING THE DEPARTMENT OF AGRICULTURE THRU SECRETARY WILLIAM DAR TO GRANT THIRTY MILLION PESOS (PhP30M) FROM ITS QUICK RESPONSE FUND TO BE USED FOR THE RESTORATION AND REHABILITATION OF AGRICULTURAL INDUSTRY WHICH WAS HEAVILY DAMAGED BY SUPER TYPHOON URSULA

"WHEREAS, on December 3, 2019, the Municipality of Bulalacao, Province of Oriental Mindoro was hit by Typhoon Tisoy under Storm Signal No. 3 which brought havoc to the residents because it ruined their houses and destroyed agriculture, livestock and fishing industries;

"WHEREAS, after three weeks, on Christmas Day to be exact, Bulalacao was again hit by Typhoon Ursula initially announced to be Storm Signal No. 3 but its not, because it was a super typhoon which brought strong winds and heavy rains to the entire municipality and lasted for three (3) hours where an estimated 90% of houses and other infrastructural facilities such as roads and bridges were washed out, 4 persons died and 4 were injured resulted to social and economic turmoil among the residents particularly the poor and the helpless families who were heavily affected by the natural calamity;

"WHEREAS, various infrastructural facilities were devastated, electricity was totally shut-down and so as the communication network and the water supply system, hospitals and school buildings suffered 90% destruction including the roro port and the public market were also damaged and residential houses reached to 90% destruction;

"WHEREAS, the Municipal Agriculture Office submitted reports on damages showing remarkable losses in agriculture and fisheries that financial assistance from higher government agency such as the Department of Agriculture is direly needed to be used for the restoration and rehabilitation of agricultural industry; Now, therefore be it....

RESOLVED AS IT IS HEREBY RESOLVED, TO: Earnestly request the Department of Agriculture thru Secretary William Dar to grant thirty million (PhP30M) from its Quick Response Fund to be used for the restoration and rehabilitation of agricultural industry which was heavily damaged by Super Typhoon Ursula;






