BULALACAO, PROVINCE OF ORIENTAL MINDORO AND  
APPROPRIATING FUNDS THEREOF

- Community benefit award - The CBSTO/FTSO that contributes to the management of tourism well for the long-term benefit of the destination and local people as well as visitors.
- Excellence in Sustainable Tourism Award – The CBSTO/FTSO with the most outstanding Site Preparedness and Visitor Management Action Plan and with the most commendable visitor management protocols, policies and guidelines implemented on their respective farm tourism site.
- Most outstanding CBSTO worker award – will be given to the president of the CBSTO receiving the Excellence in Sustainable Tourism Award.
- Most outstanding FTS operator award - will be given to the operator of the FTSO receiving the Excellence in Sustainable Tourism Award.

- The awarding ceremonies for Bulalacao Exemplary Awards for Local Tourism Stakeholders shall be annually held on the last Friday of April of every year as part of the celebration of the Bulalacao Day.
- The Community-Based Tourism Promotion and Development Division under the Municipal Cooperative Development Office shall ensure the involvement and participation of local tourism stakeholders and shall formulate the mechanics, rules, and regulations for the Bulalacao Exemplary Awards for Local Tourism Stakeholders.
- The awardees and finalist of the Bulalacao Exemplary Awards for Local Tourism Stakeholders shall be automatically nominated to the Provincial LTSEA.

**Section 5. Funding Requirements.** At least fifty thousand pesos (Php 50,000.00) shall be allotted annually for the prizes of the winning CBSTOs and FTSO under the Prizes and Awards expense under the MOOE of the Office of the Mayor.

- Destination stewardship award – Php10,000.00
- Biodiversity conservative award – 10,000.00
- Community benefit award – 10,000.00
- Excellence in Sustainable Tourism Award – 10,000.00
- Most outstanding CBST worker award – 10,000.00
- Most outstanding FTS worker award – 10,000.00




**Section 8. Effectivity.** This ordinance shall take effect upon approval.
