REVENUE CODE, 2004, CHARGES FOR PARKING**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental  
Mindoro:

**Section 1.** Section 5D.01, Article D of the New Revenue Code, 2004,  
charges for parking are hereby amended to read as follows:

<b>b. Cargo Trucks: 16 wheeler</b>	-	<b>150.00</b>
<b>10-12 wheeler</b>	-	<b>120.00</b>
<b>6-8 wheeler</b>	-	<b>100.00</b>
<b>c. Van</b>	-	<b>40.00</b>
<b>d. Tricycle/Motorcycle for hire</b>	-	<b>15.00"</b>




**Section 2.** Ordinance inconsistent hereof are hereby repealed or modified accordingly.






