**Section 3.** The posting of pictures and information of any civilian should be in accordance to the Republic Act No. 10173 otherwise known as Data Privacy Act of 2012. A clear and understandable privacy notice should be provided before capturing or processing any personal information, including photos of the civilians to be posted.

**Section 4. Penalties.** The following penalties shall be imposed on violators of this Ordinance:

- First Offense – PhP500.00
- Second Offense – 1,500.00
- Third Offense – 2,500.00

**Section 5.** This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.
