RESOLUTION NO. 61 ✓

REQUESTING THE MINISTRY OF THE BUDGET, MANILA, THROUGH THE MLGCD, CALAPAN, ORIENTAL MINDORO TO ALLOCATE THE AMOUNT OF ₱500,000.00 FOR THE CONSTRUCTION OF BULALACAO PUBLIC MARKET, BULALACAO, ORIENTAL MINDORO.

WHEREAS, the Municipality of Bulalacao, Oriental Mindoro has a small public market;

WHEREAS, due to the increase of buying public, this market needs additional construction or expansion;

WHEREAS, the Municipal Government of Bulalacao has a meager income, hence cannot afford to construct a better and good public market, without Aid from the National Government;

NOW, THEREFORE, resolved as it is hereby resolved to request the Ministry of the Budget, Manila, through the MLGCD, Calapan, Oriental Mindoro to allocate the amount of ₱500,000.00 for the construction of the Public Market of Bulalacao, Oriental Mindoro.

Section I. - There is hereby Appropriated the sum of P 8,000.00 for the following expenses:

- a) Maintenance of Municipal roads, streets, bridges and ferries - - - - - P 4,000.00
- b) Maintenance of Public Plazas, Munuments, etc- - - - - 2,000.00
- c) Supplies & materials - - - - - P 2,000.00
- TOTAL - - - - - P 8,000.00

which amount shall be appropriated out of underestimated income from Aid of the National Government for maintenance of Municipal Streets;

Section 2.- This Ordinance shall take effect immediately.
