RESOLVED, to approve the following Ordinance:

ORDINANCE NO.

ORDINANCE NO. 10

AN ORDINANCE REQUIRING ALL PERSONS, COMPANIES, AND ASSOCIATIONS WHO ARE ENGAGE IN BUY AND SELL OF ANY KINDS OF ANIMALS, SUCH AS: COWS, CARABAOS, HORSES, PIGS, CHICKENS AND ETC. TO PAY MAYORS PERMIT TO THE MUNICIPAL TREASURER, OR HIS AUTHORIZED REPRESENTATIVES BEFORE PERFORMING SUCH DUTIES WITHIN THE JURISDICTION OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AND SHALL PROVIDE FINES AND PUNISHMENT FOR EVERY VIOLATION HEREOF

SECTION 1. All persons, companies and associations who are engage in buy and sell of Large cattles and minor animals such as cows, Caraboas, horses, pigs, chickens and etc., are hereby required to pay to the Municipal Treasurer the amount of ₱150.00 annually, for every Mayors Permit issued by the Municipal Mayor thereof;

SECTION 2. Persons, companies & associations are strictly prohibited to engage and buy and sell without securing first Mayor's Permit from the Office of the Municipal Mayor;

SECTION 3. Violation of this Ordinance or parts thereof shall be fined the amount of ₱500.00 to ₱1,000.00 or imprisonment of One (1) to six (6) months or both such fine and imprisonment at the discretion of the Court;

SECTION 4. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 5. This Ordinance shall take effect immediately;
