REQUESTING GOVERNOR BENJAMIN (CHIPPY) ESPIRITY, CHAIRMAN FOR THE CONSTRUCTION OF ROAD & BRIDGES AND SCHOOL BUILDINGS, THIS PROVINCE TO INCLUDE FOR 1987 BUDGET THE CONSTRUCTION OF THE SCHOOL BUILDINGS OF BARANGAY MAASIN, BAGONG SIKAT AND SAN ISIDRO, BULALACAO, ORIENTAL MINDORO

WHEREAS, the school buildings of Barangay Maasin, San Isidro and Bagong Sikat were totally blown-down by previous typhoons;

WHEREAS, classes in these barangays are temporarily held in churches or in private houses;

WHEREAS, people in these barangays cannot afford to construct their school buildings due to lack of funds;
