RESOLUTION REQUESTING THE REGIONAL DIRECTOR, BUREAU OF FOREST DEVELOPMENT REGION IV, QUEZON CITY TO INFORM THE SANGGUNIANG BAYAN OF BULALACAO, ABOUT THE ACTION TAKEN ON RESOLUTION NO 16 SERIES OF 1986, REQUESTING THE CONVERSION OF EXISTING FOREST LANDS IN THE MUNICIPALITY INTO AGRICULTURAL LANDS

WHEREAS, Honorable Ernesto M. Maceda, Minister of Ministry of Natural Resources issued Memorandum dated June 26, 1986 to Director Ireneo L. Domingo to direct his field personnel to conduct an immediate investigation of the release of forest lands as alienable and disposable in favor of the present occupants and prepare necessary documents for final disposition;

WHEREAS, the Sangguniang Bayan of Bulalacao pinpointed the forest area for conversion to agricultural lands in the following barangays;


- a) San Isidro


