REORGANIZING THE MEMBERSHIP OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, pursuant to Section 43 par (a) of Republic Act No. 6975 otherwise known as the Department of Interior and Local Government Act of 1990, there shall be created by the sangguniang bayan in every municipality at least one (1) People's Law Enforcement Board (PLEB) which shall have jurisdiction to hear and decide citizens complaints or cases filed before it against erring officer and members of the Philippine National Police (PNP); *where the sangguniang bayan shall have jurisdiction over its composition*

"WHEREAS, the present membership of the PLEB created at this Municipality has become inactive and no longer serious in performing its duties;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan to reorganize the membership of the People's Law Enforcement Board (PLEB) in the Municipality of Bulalacao, Oriental Mindoro by confirming the appointments of new members chosen by the Association of Barangay Captains, by the Peace and Order Council and by this sanggunian; namely:
