RESOLUTION SETTING THE DATE AND FIXING THE MINIMUM BID OF PUBLIC AUCTION OF EXCLUSIVE PRIVILEGE TO FERRY ON KABURAYAN RIVER, POBLACION, BULALACAO, ORIENTAL MINDORO

" WHEREAS, Pursuant to Municipal Ordinance No. 93-036 of Bulalacao, Oriental Mindoro, exclusive privilege to ferry on Kaburayan River, Poblacion of this Municipality shall be granted to the highest bidder in public auction of the same;
