"WHEREAS, with the passage of Republic Act 7160, local government units now assume more complex roles in socio-economic development and will continue to help shape the developmental directions of the country in the 1990's and beyond rather than a mere provider of traditional basic services;

"WHEREAS, reorganization is a meaningful management intervention to operationalize the concepts of decentralization and local autonomy and to provide for structural adjustment to achieve organizational responsiveness and flexibility;

"WHEREAS, reorganization is a must as a consequence of devolution;

"WHEREAS, Bulalacao has already completed the process of devolution;

NOW THEREFORE, BE IT:

RESOLVED as it is HEREBY RESOLVED, to reorganize the organizational structure and staffing pattern of the local government unit of Bulalacao, Oriental Mindoro;
