" RESOLUTION NO. 93-01-003

"WHEREAS, all owners, operators, proprietors, managers, administrator or any person of callings are required to secure a Mayor's Permit before any business can be lawfully begun or pursued within the territorial jurisdiction of Bulalacao, Oriental Mindoro;

"WHEREAS, as a pre-requisite for the grant of Mayor's Permit, application thereof is required;

"WHEREAS, the present amount of application fee is twenty pesos only;

"WHEREAS, the Sangguniang Bayan feels that there must be an increase in the application fee in order to raise the local revenue of this Municipality;

NOW THEREFORE:

RESOLVED as it is HEREBY RESOLVED to pass the following Tax Ordinance:

TAX ORDINANCE NO. 14

AN ORDINANCE INCREASING THE AMOUNT OF APPLICATION FEE FOR MAYOR'S PERMIT

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The application fee levied to all applicants of Mayor's Permit is hereby increased from ₱ 20.00 to ₱ 25.00;

SECTION 2. The application fee must be paid to, and collected by, the Municipal Treasurer or his duly authorized representatives;

SECTION 3. Any violation of the provisions of this Tax Ordinance shall be punished by a fine of not exceeding Five Hundred Pesos (₱500.00) or imprisonment of not exceeding six (6) months or both, such fine and imprisonment at the discretion of the Court;

SECTION 4. All Ordinances inconsistent hereof are hereby repealed or modified accordingly;

SECTION 5. This tax ordinance shall take effect ten (10) days after its publication;

RESOLVED FURTHER, to furnish copies of this Resolution embodying the foregoing Tax Ordinance the Municipal Treasurer, Bulalacao, Oriental Mindoro for its implementation;


