in all the barangays of the Municipality of Bulalacao, Oriental Mindoro;


RESOLVED, FINALLY, that copies of this resolution be furnished,


THERE HAVING no other business to be transacted so on motion of Panganiban Mayot, seconded by all the members present, the session was adjourned at 12:00 noon.




