RESOLUTION REQUESTING THE HONORABLE GLORIA M. MACAPAGAL, SENATE OF THE PHILIPPINES TO ASSIST IN THE CEMENTING OF BASKETBALL COURT OF BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 13 of Article II of the Constitution provides that the State shall recognize the vital role of the youth in nation building and shall promote and protect their physical, moral spiritual, intellectual, and social well-being;
