"ORDINANCE NO. 93-12-058

CREATING A MUNICIPAL AD-HOC COMMITTEE ON "BALIK BAWANG PROGRAM" TO CAUSE THE SCREENING AND ACTUAL SELECTION OF BENEFICIARIES, IMPLEMENTATION AND MONITORING OF THE SAME IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, this municipality has witnessed the destructive effects on its agricultural and aqua-cultural produce caused by typhoon Naning;

"WHEREAS, said typhoon made an almost one hundred percent (100%) damage to garlic plantation, thus farmers of this crop as well as the entire economic prospects of this municipality are facing a major financial setbacks considering that most of them are classified as marginal farmers and this municipality's residents' buying power depends largely on the outcome of garlic production;

"WHEREAS, it is imperative to safeguard the interests of the small farmers and lend assistance to them whenever necessary;

"WHEREAS, this municipality, under Section 324 par (d) of RA7160, has allocated five percent (5%) of its estimated revenue from regular sources amounting to more than Four Hundred Thousand Pesos (P400,000.00) as an annual lumpsum appropriation for unforeseen expenditures arising from occurrence of calamities;

"WHEREAS, the creation of a special committee specially tasked to select the beneficiaries, implement the program and monitor the same, is vital in order to bring about a more efficient and effective distribution of assistance among local farmers;

NOW THEREFORE: the Sangguniang Bayan of Bulalacao, Oriental Mindoro hereby ordains:

SECTION 1. ORGANIZATION. There is hereby created a municipal ad-hoc committee on "Balik Bawang Program", hereinafter referred to as the "COMMITTEE"

SECTION 2. COMPOSITION. The committee shall be composed of the following:

- a. The Municipal Mayor, as chairman
- b. The Municipal Agricultural Officer
- c. The Municipal Social Welfare and Development Officer
- d. The Municipal Planning and Development Coordinator
- e. The Municipal Treasurer
- f. Three members of the Sangguniang Bayan namely:
 1. Senen C. Familara
 2. Rey T. Amparo
 3. Ronald S. Rondael

SECTION 3. POWERS AND FUNCTIONS. - The Committee shall have the following powers and functions:

- a. Screen and select prospective beneficiaries;
- b. Cause or direct the proper distribution of garlic planting material;
- c. Monitor the progress of the implementation of the program;
- d. Collect loaned planting materials from each farmer beneficiary.
- e. The committee is hereby empowered to call upon any officer of the municipal government for such assistance as it may need in the discharge of its functions;
- f. Perform such other functions as the Sangguniang Bayan may assign.

SECTION 4. FUNDING.- The committee shall be provided with an initial allocation of Two Hundred Thousand Pesos (P200,000.00) to be drawn from the Contingency Reserve of this municipality;

SECTION 5. OPERATING GUIDELINES. - The committee shall adopt such operating guidelines as may be necessary to implement this ordinance;

SECTION 6. EFFECTIVITY. - This ordinance shall take effect immediately.

ON MOTION of Hon. Rey T. Amparo duly seconded by Hon. Oscar C. Familara this Ordinance is ENACTED this 13th day of December, 1993 at Bulalacao, Oriental Mindoro.
