REQUESTING SENATOR RAUL S. ROCCO, TO ALLOCATE FUND FOR THE  
CONSTRUCTION OF THREE (3) CLASSROOM SCHOOL BUILDING FOR  
CAMBUNANG ELEMENTARY SCHOOL, CAMBUNANG, BULALACAO,  
ORIENTAL MINDORO

"WHEREAS, education is essential to nation building  
as acknowledged by Section 17, Article II in the Declara-  
tion of State Policies of the Constitution which provides  
that the State shall give priority of education, science  
& technology, arts, culture & sports to foster patriotism,  
nationalism and development. It further provides that  
the State shall assign the highest budgetary priority to  
education and that quality education be made available to  
all;

"WHEREAS, quality education could only be achieved  
through the provision of right and adequate opportunities  
to develop the students spiritually, morally, mentally and  
socially so that they can cope effectively with the  
increasingly technological world of computer era;

"WHEREAS, the Cambunang Elementary School in the Muni-  
cipality of Bulalacao, Province of Oriental Mindoro direly  
needs an additional three (3) classroom building in order  
to meet the demand of the increasing enrollees;

"WHEREAS, it is believed that the provision of addi-  
tional classroom at the abovementioned school shall help  
enhance the learning and teaching conditions of both the  
students and teachers of this school; Now, therefore, be it
