REQUESTING MELINDA S. ALVIOR, REGIONAL DIRECTOR, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REGIONAL OFFICE NO. 4, TO ALLOCATE THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1.5 M) FOR THE CONSTRUCTION OF AN EVACUATION CENTER IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is the prime duty of the State to serve and protect the people against the damage of lives and properties and to adopt measures for the promotion of the general welfare of its people essential for the enjoyment and fulfillment of the blessings of democracy;

"WHEREAS, it is a sad experience that the Municipality of Bulalacao, Province of Oriental Mindoro suffered extreme and various losses brought by the El Niño and La Niña Phenomena which brought distress, hunger and misfortune among its people;

"WHEREAS, taking into consideration the sufferings, agony and damages, the humanity could possibly get from these calamities, the government must prepare itself to protect its constituents from the anguish emanating from these disasters by adequate preparation, proper planning and acquiring an evacuation center to house the evacuees during the occurrence of calamity;

"WHEREAS, hounded with financial constraints, the above noble objective could only be realized through the assistance of the higher government agencies; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request Melinda S. Alviar, Regional Director, Department of Social Welfare and Development, Regional Office No. 4, to allocate the amount of One Million Five Hundred Thousand Pesos (P1.5 M) for the construction of an evacuation center in the Municipality of Bulalacao, Province of Oriental Mindoro;
