EARNESTLY REQUESTING THE HONORABLE ANDREW GONZALES, SECRETARY, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO CREATE THREE PLANTILLA POSITIONS OF SUPPORT PERSONNELS SUCH AS OFFICE CLERK, UTILITY WORKER AND SECURITY GUARD FOR THE BULALACAO NATIONAL HIGH SCHOOL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AND APPROPRIATING FUNDS THEREFOR

"WHEREAS, Section 17, Article II of the Constitution provides that the State shall give priority to education, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

"WHEREAS, the appointment of three support personnels such as Office clerk, Utility worker and Security guard in the Bulalacao National High School would lessen the task of the teachers and students who still have various important classroom activities to attend to;


