REQUESTING ATTY. EDGARDO C. ACERON, CALAPAN CITY TO RENDER LEGAL OPINIONS AND RECOMMENDATIONS ON THE CASE FILED AGAINST MRS. NORMA SAGUN AND ON CIVIL CASE NO. 255 ENTITLED 'RODOLFO V. DAYANGHIRANG ET AL VERSUS THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO'

'WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro sued Mrs. Norma Sagun for issuing a bouncing cheque as payment for the fishery zone awarded to her after the conduct of a public auction thereof;

'WHEREAS, such dishonesty of Mrs. Sagun incurred losses to the Municipal Government in the amount of Seventy Five Thousand Pesos (P75,000.00)'

'WHEREAS, in addition to the above, the Municipal Government of Bulalacao has a pending case in the Regional Trial Court, Branch 42 in Roxas, Oriental Mindoro which is Civil Case No. 255 entitled "Rodolfo V. Dayanghirang, et al versus the Municipal Government of Bulalacao;











