EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES TO INCLUDE THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE REDUCTION OR EXEMPTION OF THE PURCHASE POWER ADJUSTMENTS (PPA)

“WHEREAS, electrical energy plays a vital role in every Filipino home for they have come to enjoy the comfort and convenience that electrical appliances and fixtures provide;

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was declared as a Pro-Poor Municipality pursuant to Executive Order No. 370 is approximately composed of 24% Hanunuo Mangyans who do not have definite income for everyday living;

“WHEREAS, life becomes more difficult each day that the residents herein could hardly cope-up with their basic needs that additional expenses such as that of the Purchase Power Adjustments (PPA) in their electric bills is an added burden considering that their income solely depends on fishing and farming only;


