EARNESTLY REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, PROVINCIAL GOVERNOR THRU THE HONORABLE THADDEUS VENTURANZA, VICE GOVERNOR AND PRESIDING OFFICER, SANGGUNIANG PANLALAWIGAN TO PRIORITIZE THE CONCRETING OF ONE HUNDRED FIFTY METERS (150 ML) ROAD FROM THE SOUTH JUNCTION TO THE BULALACAO COMMUNITY HOSPITAL, BULALACAO, ORIENTAL MINDORO

“WHEREAS, the road from the South Junction to the Bulalacao Community Hospital which is approximately 150 meters remains to be rugged to the inconvenience of both the medical staff and the patients of that hospital;

“WHEREAS, going up to the hospital in times of emergency is so difficult that concreting of the abovementioned road is indispensable;


