**RESOLUTION NO. 02-02-015**

**A RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPAL GOVERNMENT IN ENTERING INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THRU ITS PROVINCIAL DIRECTOR FOR THE IMPLEMENTATION OF THE POVERTY REDUCTION PROGRAMS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS,** the Local Government Unit play the significant roles in the fight against poverty either as implementor, co-implementor or facilitators;

**“WHEREAS,** RA 8425 mandates the Local Government Units through the Local Development Councils to formulate, implement, monitor and evaluate poverty reduction programs in their respective jurisdictions, consistent with the poverty reduction strategy of the national government;

**“WHEREAS,** the Department of the Interior and Local Government in its effort to refocus its program toward poverty reduction is mandated to coordinate with the concerned national;

**“WHEREAS,** the DILG should oversee, monitor and recommend measures to ensure the effective formulation, implementation and evaluation policies, programs and management of poverty alleviation programs;


**“WHEREAS,** the DILG Region IV has developed a flagship program entitled ‘Kapit-Bisig Laban sa Kahirapan (KALAHI) designed to integrate and synchronize anti-poverty interventions/programs of the government, the non-government organizations, the private sector and community to strengthen efforts to fight poverty in selected urban and rural communities in Region IV; Now, therefore, be it


