REQUESTING THE SANGGUNIANG PANLALAWIGAN TO ALLOCATE
FUNDS FOR THE CASH GIFTS OF BARANGAY HEALTH WORKERS OF THE
MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

“WHEREAS, under Section 17 of RA 7160, local government units shall exercise and discharge functions and responsibilities which are necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities such as those pertaining to general hygiene and sanitation, beautification and solid waste management;

“WHEREAS, the same provision, however, extends the powers to implement the program and projects of the primary health care, maternal and child care and communicable and non-communicable disease control services which in the long run fall to the greater responsive, moral and official duty of our lowly barangay health workers;

“WHEREAS, under Section 393 of the same law, stating therein the benefits of barangay appointive officials shall be granted insurance or other benefits during their incumbency, however, due to the financial difficulties of this component barangays of this Municipality and to think of the shortage of the financial resource that could be used by the municipal government to extend those kind of benefits, it is constraint to request the provincial government for that much needed financial assistance for subsidy; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Sangguniang Panlalawigan to allocate funds for the cash gifts of Barangay Health Workers of the Municipality of Bulalacao, Oriental Mindoro;
