DECLARING THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO UNDER THE STATE OF CALAMITY

"WHEREAS, pursuant to the Rules and Regulations Implementing Republic Act No. 8185 "An Act amending Section 324 (d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that the Sangguniang Bayan concerned may declare the area affected by the calamity under the State of the Calamity.

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro suffered extreme and various losses in agricultural produce, livestock and fishing industries cause by the typhoon Uding which brought distress, hunger and misfortune among its inhabitants,

"WHEREAS, the Local Disaster Coordinating Council was establish Pursuant to PD 1566 is tasked to carry out relief operations, rehabilitations and various related activities during and after the occurrence of a calamity desires to take appropriate steps to restore the normal living conditions of the community affected by the calamity through the disbursements of the 5% Calamity Fund intended for the purposes stated herein. Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To Declare the Municipality of Bulatacao, Province of Oriental Mindoro under the State of Calamity and allow barangay governments to use their own 5% Calamity Fund out of their Barangay Annual Budget.
