"WHEREAS, the Municipality of Bulalacao which is situated in the southernmost tip of the Province of Oriental Mindoro needs various infrastructural facilities towards social and economic development;

"WHEREAS, it has been an arduous desire of the Municipality of Bulalacao to improve its temporary landing center through the construction of a permanent feeder port to serve the incoming and outgoing cargoes, passengers and fishing boats;

"WHEREAS, along with the construction of the feeder port, equally important is the cementing of an access road from Poblacion proper going to the port to facilitate the passage of jeepneys and cargo trucks transacting at the port;
