EARNESTLY REQUESTING SENATOR JUAN PONCE ENRILE, SENATE PRESIDENT, REPUBLIC OF THE PHILIPPINES TO PROVIDE THE REQUIRED LOCAL COUNTERPART CONTRIBUTION OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO IN THE AMOUNT OF PHP1,554,000.00 TO BE USED FOR THE COMPLETION OF THE TYPE "B" PNP BULALACAO MUNICIPAL POLICE STATION

"WHEREAS, it is a declared policy of the State to promote peace and order, ensure public safety and further strengthen local government's capability and towards this end, the State shall bolster a system of coordination and cooperation among the citizenry, local executives and the integrated law enforcer and public safety agencies created under R.A. 6975;


"WHEREAS, in conformity with the abovementioned Constitutional mandate, the Municipal Government of Bulalacao, Oriental Mindoro purchased a parcel of lot which is solely intended for a PNP Station and tapped all possible sources for its final construction however, needs an additional fund in the amount of Php1,554,000.00 for its completion;

"WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro being the Pro-Poor Municipality pursuant to Executive Order No. 370 is hounded with financial constraints that assistance from the higher government officials is direly needed. Now, therefore, be it




