HERNANDEZ, CHIEF, OFFICE OF THE PLANNING SERVICE, PHYSICAL FACILITIES SCHOOLS ENGINEERING DIVISION (PFSED), DEPARTMENT OF EDUCATION TO ALLOCATE ONE (1) CLASSROOM BUILDING EACH FOR THE THREE RED-COLOR CODED ELEMENTARY SCHOOLS NAMELY: UPPER YUNOT ELEMENTARY SCHOOL, CAMPAASAN ELEMENTARY SCHOOL AND TAMBANGAN ELEMENTARY SCHOOL, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that quality and basic education be made available and accessible to all;

"WHEREAS, Upper Yunot Elementary School, Campaasan Elementary School and Tambangan Elementary School, all of the Municipality of Bulalacao, Province of Oriental Mindoro need additional classroom building to house and accommodate the increasing enrollees thereat reaching up to more than 75 pupils in a room;

"WHEREAS, it is sadly to learn that Waring Primary School and Agong Elementary School, all of the Municipality of Bulalacao, Province of Oriental Mindoro which ranked 1 and 2 by the Basic Education Information System (BEIS) were already granted with additional classroom buildings so that the three schools mentioned above a dream realized to have additional classrooms for they ranked third, fourth and fifth by the BEIS;


