**RESOLUTION NO. 08-02-029**

**RESOLUTION EARNESTLY REQUESTING SECRETARY FRANCISCO T. DUQUE, III OF THE DEPARTMENT OF HEALTH TO ASSIGN A MEDICAL PRACTITIONER/DOCTOR TO THE BARRIO TO AUGMENT THE DEPLETED HEALTH FORCE IN THE DELIVERY OF BASIC HEALTH SERVICES TO THE UNDEPRIVILEGED SECTOR SEEKING MEDICAL ATTENTION/ASSISTANCE AT THE BULALACAO COMMUNITY HOSPITAL, BULALACAO, ORIENTAL MINDORO**

**"WHEREAS,** it is a Constitutional mandate that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**"WHEREAS,** Bulalacao, Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 is approximately composed of twenty percent *hanunuo mangyans* who do not have access to proper medical treatment and services due to poverty;

**"WHEREAS,** it is sadly observed that there exist alarming health hazards within the community particularly dengue and filariasis which need to be immediately addressed to in order to save precious human lives;


**"WHEREAS,** it had been proven in the past that rural medical services rendered by the so-called "Doctors to the Barrio" was of great help in arresting various medical problems of the rural folks, thereby alleviating their health conditions towards their social and economic development and of the community in general;

"WHEREAS, considering that there is only one community hospital in the Municipality of Bulalacao, Oriental Mindoro manned with only one physician, it is highly beneficial if this hospital be augmented with the services of these Doctors to the Barrio; Now, therefore, be it


