EXPRESSING THE SENSE OF GRATITUDE OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO THE HONORABLE ALFONSO V. UMALI, JR., CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO, HOUSE OF REPRESENTATIVES FOR FINALLY APPROVING ON ITS 3RD AND FINAL READING "AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO BE KNOWN AS SAN ROQUE NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR"

"WHEREAS, the current patterns of social and economic development being undertaken by the National Government is based upon a structural system of priorities of all continuing, coordinated, and fully integrated social and economic plans and programs; one of which is the continuing improvement of education system;

"WHEREAS, the improvement of secondary education is one of the goals of the Government's educational development programs, consistent with the Constitutional mandate that it shall be given the highest budgetary priority and make such available and free to every Filipino;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro has made strong representation and clamor for the establishment of San Roque National High School, funded by the National Government to insure its continuous operations;

"WHEREAS, "An Act Establishing a National High School in Barangay San Roque, Municipality of Bulalacao, Province of Oriental Mindoro to be known as San Roque National High School, and appropriating funds therefor" has been passed by the House of Representatives on Third Reading through the initiative of Congressman Alfonso V. Umali, Jr.;
