



3. Improvement of Bulalacao Bay Park thru Construction of Jogging Lanes and Drainage System of the Whole Area of Buulalacao Bay Park which measures around seven (7) hectares	15,000,000.00
4. Acquisition of one (1) unit of brand new, locally-manufactured Complete Drilling Machine for Ground Water	5,000,000.00
5. Improvement of Bagong Sikat Falls thru Construction of Masonry Walls for four (4) swimming areas	10,000,000.00
6. Purchase of ± fourteen (14) hectares of lot in Barangay Poblacion, Bulalacao	20,000,000.00






