EARNESTLY REQUESTING THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE TO ALLOCATE VARIOUS AGRICULTURAL INPUTS FOR THE MARGINAL FARMERS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a vast agricultural land whose major source of income of the residents is farming;

"WHEREAS, it is sadly noted that out of this area, only 80% is utilized for agriculture due to lack of certain agricultural support facilities such as that of a functional irrigation system coupled with the difficulties of the farmers to cope-up with the increasing prices of agricultural inputs such as fertilizers, pesticides and fungicides;

"WHEREAS, the allocation of certified seeds or hybrid seeds of palay to farming municipalities appeared to be encouraging and beneficial, but equally important is the allocation of various agricultural inputs essential to increase production needed to achieve food security and stability; Now, therefore, be it
