RESOLUTION NO. 09-01-007

INDORSING AND REQUESTING PREFERENTIAL TREATMENT FOR PRINCIPAL POSITION FOR EITHER CABUGAO ELEMENTARY SCHOOL OR BENLI ELEMENTARY SCHOOL BOTH IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, a professional and contented teaching force is essential to the success of an education system, that is to ensure that teaching will attract and retain its rightful share of the best available talents through adequate remuneration and other means of job satisfaction and fulfillment, as commanded by the Constitution;

“WHEREAS, for this purpose and for the success of the educational enterprise everyone is tasked, especially the State, to carry out the stake in the quality of the nation’s formal education;

“WHEREAS, promotion is rightly given to any employee as recognition for his competence, merits and other relevant considerations as shown by his efficiency and effectiveness on particular job he holds;

“WHEREAS, it is noted that the required number of teachers for the position of principal is met by Cabugao and Benli Elementary Schools and the required consultation with the Local School Board under Section 99 par. D of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 where it was provided that the Department of Education shall consult the Local School Board the appointment of division superintendent, district supervisor, school principals and other school officials was duly complied with;

“WHEREAS, the barangay elementary schools of both Benli and Cabugao suffer poor results in the academic parameters set by the DepEd due, perhaps to inadequate supervision of the teachers who are responsible for educating the children of those living in the hinterlands and belonging to indigenous minorities of hanunuo mangyans;

"WHEREAS, it is prudent that the far-flung elementary schools situated at Barangays Cabugao and Benli be given a preferential treatment in the appointment of a principal thereto to implement the need for close monitoring of the teachers performance as well as the intellectual growth of the children to whom the future of this country lies; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Indorse and request preferential treatment for principal position for either Cabugao Elementary School or Benli Elementary School both in the Municipality of Bulalacao, Province of Oriental Mindoro;

RESOLVED FURTHER, To: Let copies of this resolution be furnished the Regional Director, Department of Education, Dr. Estrellita A. Dolor, Schools Division Superintendent, Province of Oriental Mindoro and Mrs. Celestina Patulot, District Supervisor, Bulalacao School District, for their information and kindest consideration;


