RESOLUTION REQUESTING THE DSWD AND THE PSWDO TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF TOTALLY WIPED-OUT AND THE REHABILITATION OF DAMAGED SCHOOL BUILDINGS IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO PARTICULARLY THOSE AT SITIOS LIBTONG AND BATING

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was not spared on the damage incurred from the onslaught of the Super Typhoon Yolanda;

“WHEREAS, reports reached this Sanggunian that several school buildings in this Municipality, most of them were already in a dilapidated state, were either severely damaged or totally wiped-out by Super Typhoon Yolanda;

“WHEREAS, repair of those school buildings as construction of new ones is necessary not only for academic purposes but likewise they serve as precincts during electoral exercises and as evacuation camps in the event of disasters;

“WHEREAS, such repair and construction are beyond the financial capability of this Pro-Poor Municipality that relies more of its budget from the Internal Revenue Allotment (IRA); Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the DSWD and the PSWDO to allocate the necessary funds for the construction of totally wiped-out and the rehabilitation of damaged school buildings in the Municipality of Bulalacao, Oriental Mindoro particularly those at Sitios Libtong and Bating;






