### **RESOLUTION NO. 21-10-313**

**RESOLUTION ADOPTING THE YAKAP BAYAN FRAMEWORKS OF INTERVENTION AS THE STRATEGY OF THE MUNICIPALITY OF BULALACAO IN DRUG ABUSE REHABILITATION AND AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE LOCAL GOVERNMENT UNIT OF BULALACAO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL OFFICE REPRESENTED BY ITS REGIONAL DIRECTOR, FERNANDO R. DE VILLA, JR., CESO III TO ESTABLISH THE PROGRAM AT THIS MUNICIPALITY**

**“WHEREAS**, following the main thrust of President Rodrigo Roa Duterte to eradicate the illegal drug menace, the Department of Social Welfare and Development (DSWD) thru the Office of Assistant Secretary Jose Antonio R. Hernandez developed the Yakap Bayan Framework of Intervention;

**“WHEREAS**, the DSWD conducted a process documentation of six (6) sites where it was found that the implementation of the Yakap Bayan Framework of Intervention had been successful due to the adoption of strategy that provides a clear direction and trajectory, integrate the local culture into solutions and utilizes available resources of local government units and other stakeholders to provide a concrete and sustainable system of rehabilitation, reintegration and continuum of care for Recovering Persons Who Used Drugs (RPWUDs) and support measures for the strengthening of families and communities;

**“WHEREAS**, the Yakap Bayan Framework of Intervention carries the essence of the Executive Order No. 15, series of 2017 and exemplifies a unified and coordinated multi-sector and multi-perspective approach necessary to create a fail-safe solution to the nationwide drug problem;

**"WHEREAS**, the drug menace is viewed as a window of opportunity for nation-building from the barangay/grassroots up to the national level, to guarantee a peaceful, comfortable and just society for the next generation such that we choose not to follow the mainstream approach and instead develop a Rights-Based approach now recognized as intrinsic to the framework;

**"WHEREAS**, the goal of Yakap Bayan is to transform the drug surrenderers into volunteers, advocates, and leaders as they undergo trainings and seminars after rendering community services, including concern and compassion in their hearts as the community starts to embrace and accept them back;

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Adopt the Yakap Bayan frameworks of intervention as the strategy of the Municipality of Bulalacao in drug abuse rehabilitation and authorizing the Municipal Mayor to represent the Local Government Unit of Bulalacao to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), Regional Office represented by its Regional Director, Fernando R. de Villa, Jr., CESO III to establish the Program at this Municipality;
