RESOLUTION NO. 14-01-004

A RESOLUTION ADOPTING THE MUNICIPAL TRANSITION PLAN (MTP) CREATED AND APPROVED BY THE MUNICIPAL TRANSITION PANEL SPEARHEADED BY THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) IN THE EFFICIENT AND EFFECTIVE IMPLEMENTATION OF PROJECTS AND PROGRAMS FOR THE BENEFICIARIES OF PANTAWID PAMILYANG PILIPINO PROGRAM (PPPP) IN THE MUNICIPALITY OF BULALACAO

“WHEREAS, Section 16 and 17 of the Local Government Code provides for the role of the Local Government Unit (LGU) in the fight against poverty which include promotion of health and safety, enhancement of people's rights to a balanced ecology, promotion of economic prosperity and social justice, and maintenance of peace and order and comfort and convenience of their inhabitants among others;

“WHEREAS, the Local Government Unit and the Department of Social Welfare and Development in partnership with other agencies and organizations are equally mandated to spearhead poverty reduction measures and implement interventions and programs for the welfare and interest of the people in the locality, particularly the indigents;

“WHEREAS, the Municipality of Bulalacao is a recipient of Pantawid Pamilyang Pilipino Program being implemented by the DSWD which requires the establishment of an Municipal Transition Plan (MTP) for the graduating beneficiaries by pursuing the active participation of the LGU and other concerned agencies and organizations in detailing the mechanism for program complementation, resource sharing and resource generation;

“WHEREAS, this representation understands that the basic and primary responsibility of the MTP is **“to improve the well-being of the Pantawid Pamilya beneficiaries from Survival to Subsistence or to Self-Sufficiency through programmed interventions that may improve their livelihood or increase their income-generating capacities and the larger community”**;

“WHEREAS, in order to efficiently and effectively implement the comprehensive interventions, a participatory local planning process through a convergence of various national agencies including the LGU, parent leaders and non-government organizations spearheaded by DSWD have been established as Municipal Transition Team/Panel who planned and created the transition strategy being presented in this Body;

“WHEREAS, this Body in ensuring the accountability and sustainability of the MTP, it hereby passes this piece of legislation for its adoption and enjoining all Local Government Units and concerned agencies and organizations to work in partnership with DSWD for the efficient and effective implementation of programs stipulated in the MTP relative to poverty alleviation in the Municipality of Bulalacao; Now, therefore, be it


