RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO, FOR CALENDAR YEAR 2021

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that local government unit can exercise powers necessary for its efficient and effective government essential to the promotion of the general welfare of its constituents;


"WHEREAS, Section 106 of the same law states that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian. For the purpose, the development council shall assist the corresponding sanggunian in sitting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

"WHEREAS, on August 17, 2021, the Municipal Development Council composed of all punong barangays, representatives from sectoral group and other concerned municipal officials and employees convened in order to identify and prioritize programs and projects which are more important in the effective and efficient delivery of basic services to the people of Bulalacao. These programs and projects amounting to PhP252,270,000.00 which form part of MDC Resolution No. 05-2021 have undergone review, assessment and evaluation. These are likewise aligned with the recommendations and guidelines set forth by the National Government; **Now, therefore, be it**


