RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THRU THE SOUTHERN MINDORO ENGINEERING DISTRICT OFFICE, ROXAS, ORIENTAL MINDORO TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF FLOOD CONTROL MITIGATION PROJECT OF CAWAKAT RIVER IN CAMBUNANG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

"WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro, has 15 barangays 8 of which are coastal barangays, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

"WHEREAS, the flood control methods are used to reduce or prevent the detrimental effects of flood waters, flood relief methods are used to reduce the effects of flood waters or high water levels;






