WHEREAS, the Department of Environment and Natural Resources (DENR) is partnering with Local Government Units (LGUs) in the conduct of land titling in an effort to fast track the processing and issuance of land titles over in alienable and disposable lands;

WHEREAS, the DENR partnership with the LGUs provides opportunity for the LGUs to take an active role in the agency's programs-local government units have critical role to play in the implementation of national programs and projects as provided by the Local Government Code, and one of these is land titling where their help is important particularly in resolving boundary conflicts;

WHEREAS, under the DENR Administrative Order No. 2011-06 entitled "Prescribing the guidelines for the implementation of public land titling in partnership with the local government units", all the regional executive directors of the DENR are authorized to deputize permanent LGU officials that may be assigned to the titling program as Deputy Public Land Inspectors (DPLI);


