**"WHEREAS**, the Municipality of Bulalacao is on its way to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both government and private sectors are applied and gathered together to deliver the best positive outcome;

**"WHEREAS**, Bulalacao is a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**"WHEREAS**, the Local Government Unit of Bulalacao is focused and steadfast in improving the infrastructure projects and development programs of the municipality as a whole by prioritizing the completion of road constructions that are beneficial to its people;


