### **RESOLUTION NO. 21-12-419**

**STRONGLY RECOMMENDING TO THE DEPARTMENT OF HEALTH, REGION IV-MIMAROPA THROUGH ITS REGIONAL DIRECTOR, DR. MARIO S. BAQUILOD THE APPOINTMENT OF MISS PEARL ARNETTE R. AXALAN TO THE POSITION OF DEVELOPMENT OFFICER IV UNDER PERMANENT STATUS TO BE ASSIGNED IN THE MUNICIPALITIES OF ROXAS, MANSALAY AND BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, pursuant to Section 15, Article II of the 1987 Constitution, the State shall protect and promote the right to health of the people and instill health consciousness among them;

**“WHEREAS**, as a guiding principle mentioned in Section 2 of Executive Order No. 138, all department secretaries and agency heads concerned shall in pursuit of the full devolution of functions to the LGUs, conduct a functional and organizational review of their respective mandates guided by the following principles:

- i. The role of the National Government [NG] is to set the national policy, development strategy and service, delivery standards and to assist, oversee and supervise the LGUs complementary to the stronger implementing role that the LGUs shall assume by reason of devolution;

- ii. The NG, in close collaboration with the LGUs through their respective leagues shall formulate and pursue an institutional development program to support the LGUs in order to strengthen their capacities and capabilities to fully assume the devolved functions based on RA 7160 and other relevant laws;

**“WHEREAS**, Section 102 of R.A. 7160, otherwise known as the Local Government Code of 1991 states that there shall be a representative from the Department of Health in the municipality as member of the Local Health Board;

**“WHEREAS**, it is learned that the position of Development Officer IV will be vacant in January, 2022 due to the retirement of Miss Luningning M. Vendiola that this Sanggunian is humbly recommending Miss Axalan for the position as shown by her dedication, hardwork and responsive delivery of health programs and activities particularly during pandemic where she exerted more efforts and spent sleepless nights and days to formulate measures and strategies to combat the threat of Covid-19;

**“WHEREAS**, Miss Pearl Arnette R. Axalan is a nurse by profession, a bonafide resident of Bulalacao, Oriental Mindoro, a person of good moral character and a family who are into public service that her appointment would definitely brought inspiration and hope to the people who she served with care and compassion;

**“WHEREAS**, Miss Axalan is a DOH representative under Job Order status for seven [7] long years in the Province of Oriental Mindoro that her brilliant records of service is commendable and laudable and knowing that since 2014, there is no permanent position of Development Officer IV in Bulalacao that her appointment is direly needed; **Now, therefore, be it...**
