RESOLUTION REQUESTING PROVINCIAL GOVERNOR HUMERLITO "BONZ" A. DOLOR TO ALLOCATE NECESSARY FUNDS FOR THE CONSTRUCTION OF BARANGAY HEALTH CENTER AT BARANGAY SAN FRANCISCO, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities, as such for barangays it includes health and social welfare services which include maintenance of barangay health center and daycare center;

"WHEREAS, Bulalacao, a 3rd class municipality hounded with financial constraints which is located at the southernmost tip of the province of Oriental Mindoro, it has a municipal government that provides adequate facilities for the physical development of the community and uplifts the general health condition of the people;

"WHEREAS, Barangay San Francisco is one of the smallest and depressed barangays in the Municipality of Bulalacao that has no health center to provide immediate and efficient medical care and services to its community;


"WHEREAS, the provision of a health center in Barangay San Francisco would not only be beneficial in accommodating medical needs of the barangay but it would also uphold the structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...


