RESOLUTION NO. 20-10-440

RESOLUTION REQUESTING SENATOR CYNTHIA VILLAR, PHILIPPINE SENATE COMMITTEE CHAIRMAN ON AGRICULTURE, FOOD AND AGRARIAN REFORM TO FACILITATE THE CONSTRUCTION OF A NFA WAREHOUSE IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

"WHEREAS, the National Food Authority is vested the functions of ensuring the food security of the country and the stability of supply and price of the staple grain-rice;

"WHEREAS, Bulalacao, is a 3rd class municipality geographically located in the southernmost tip of the Province of Oriental Mindoro and approximately 45 km. away from the nearest NFA warehouse in Roxas, Oriental Mindoro;

"WHEREAS, Bulalacao has a total of 10,325.80 hectares agricultural land area and there are 6,016 individuals employed in agricultural sector;

"WHEREAS, since there is no NFA warehouse in Bulalacao it is a challenge for its farmers to have a good warehouse and distribution system which includes protection from insects, rodents and birds, ease of loading and unloading, efficient use of maintenance and management, and prevention of moisture re-entering the grain after drying;

"WHEREAS, given the strategic advantage of NFA warehouse and the important role it plays in providing convenience for the farmers, it is but important to construct a NFA warehouse within the Municipality in an identified and allotted lot by the Local Government of Bulalacao, Oriental Mindoro;

NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED, To: request Senator Cynthia Villar, Philippine Senate Committee Chairman on Agriculture, Food and Agrarian Reform to facilitate the construction of a NFA warehouse in the Municipality of Bulalacao, Province of Oriental Mindoro.
